## **Executive summary**

City of Newcastle (CN) sought community feedback on the draft Civic Public Domain Plan (PDP) between 16 April and 29 May 2025.

CN developed the Civic Precinct Public Domain Plan (PDP) to guide the revitalisation of one of the city's most significant civic and cultural areas. The precinct is centred around key landmarks such as Civic Park, Wheeler Place, and Newcastle City Hall and is a focal point for public life, governance, arts, and heritage. The purpose of the PDP is to establish a clear, community-informed framework that enhances public spaces, improves access and connectivity, celebrates cultural identity, and supports long-term sustainable growth.

The plan outlines several key objectives. It seeks to reinforce the precinct's status as Newcastle's cultural and civic heart by enabling greater opportunities for public art, performances, and community gatherings. The plan also aims to improve the pedestrian and cycling experience by upgrading existing infrastructure and introducing new dedicated cycleways and shared paths. Enhancements to landscaping and the inclusion of green infrastructure are proposed to create cooler, more welcoming outdoor spaces suitable for both everyday use and public events.

Heritage protection and recognition of Indigenous cultural values are also integral to the plan. It aims to preserve important sightlines, protect historic structures, and embed the precinct's diverse cultural narratives into the design of public spaces.

This consultation report summarises the community engagement activities undertaken during the consultation period and captures the feedback received from residents, stakeholders, and community organisations. The consultation process included online submissions, 'walkshops' through the precinct and pop-up events across the region. Feedback has been critical in shaping the priorities and refining the draft plan to ensure it reflects the needs and aspirations of the broader community.

The Civic Precinct Public Domain Plan represents an important step toward creating a connected, inclusive, and vibrant city centre. Through thoughtful planning and active community input, the City of Newcastle aims to deliver a precinct that honours its heritage, enriches cultural life, and enhances the experience of all who live in, work in, and visit the area.

#### What we heard

CN received 81 responses via our online feedback form.

Overall, feedback across the consultation activity revealed high levels of support for:

- · Updates to the existing parks and open space
- Upgrades to existing plazas
- Inclusion of pedestrian friendly shared zones
- Increase in tree canopy
- Improvements to pedestrian crossings
- Upgrades to cycle routes and cycle ways
- Additional shared pathways
- Inclusion of alfresco dining options

While changes to parking were slightly less supported, traffic changes across King, Aukland, Darby and Laman Streets were largely supported.

Consistent themes across the open-ended responses were:



- Pedestrian and cyclist safety and prioritisation with comments generally supporting
  greater pedestrian priority, expecting it to make the city safer, more attractive, and easier to
  access on foot or by bike. Many see this as a way to reduce traffic and support local
  businesses. Some feel that shared paths can create conflicts between fast-moving bikes and
  pedestrians. Suggestions include clearer rules, speed limits, better separation, and traffic
  calming to protect walkers.
- Tree canopy and green space with comments generally supporting the creation of a greener urban environment.
- Activation and revitalisation was another consistent theme across the feedback captured
  with many respondents talking about the importance of vibrancy, culture, connectivity and
  events.

While we strive to meet community and stakeholder needs, projects must also balance technical constraints, costs and overall project objectives to ensure a safe, functional and sustainable outcome.

#### **Next steps**

City of Newcastle will now review all feedback received during this stage of consultation. We will explore opportunities to refine the draft plan in response to community and stakeholder input, ensuring it reflects local needs and priorities wherever possible.

Once these refinements are considered, the updated draft will be submitted to Council for adoption.

We thank everyone who contributed their time and insights and look forward to continuing this conversation as the project progresses.



## 1. Background

In 2010, Council endorsed the <u>Hunter Street Revitalisation Strategic Framework</u> which identified the Civic Public Domain Plan (PDP) as a catalyst project. The Civic Precinct is home to key civic and cultural landmarks such as City Hall, Civic Theatre, Newcastle Museum, and Civic Park, and has undergone significant transformation over the past decade, including the introduction of the Newcastle Light Rail and major University of Newcastle-led developments.

Recognised as the city's cultural heart, the Civic Precinct is central to the <u>City Centre Revitalisation Plan</u>, which aims to create a vibrant, connected, and liveable urban environment. The PDP will provide a coordinated vision for the public domain, supporting better alignment with private development and long-term infrastructure planning.

City of Newcastle has developed a draft PDP that integrates key strategic policies to ensure strong connections with surrounding public spaces are delivered. The PDP aims to enhance the precinct's role as Newcastle's centre for art, culture, and heritage.

The feedback provided by the community and stakeholders during the community consultation for the draft Civic Public Domain Plan is detailed in this report.

## 2. Engagement objectives

We heard from the community through our engagement activities from 16 April to 29 May 2025.

The purpose of the engagement was to:

- Inform the community about the development of the draft Civic Public Domain Plan.
- Collaborate with key stakeholders to achieve a shared vision for the Civic Precinct.
- Seek input and feedback from the general community and stakeholders on the strategic plans and vision for the Civic Precinct.
- Deliver authentic engagement opportunities for the community to have their say.
- Strengthen relationships and build trust between community members, key stakeholders and City of Newcastle.
- Deliver accessible engagement opportunities for the community to participate in.



## 3. Communication and promotion



During the engagement period, a communications campaign informed the community of the project and promoted the opportunity for people to provide feedback.

#### 3.1 Summary of promotional activity and reach

## 4. Engagement activities





The community was invited to provide their feedback on the draft Civic Public Domain Plan from 16 April until 29 May 2025.

The community was able to provide participate in a number of ways:

#### Online feedback form

An online feedback form was delivered via the Have Your Say website. The form asked participants their level of support for each of the elements identified within the draft PDP. In total, **81** responses were submitted via the online form.

#### Walkshops through the Civic Precinct

Two walkshops were hosted which included a walk through the Civic Precinct to discuss opportunities, considerations and outcomes sought. These walkshops were timed to provide an afternoon and evening experience of the Precinct.

In total, 11 people participated in the events.

#### Speaking to the team

Six pop-up activations were held during the consultation period. These activations were designed to capture feedback from a diverse range of residents across a variety of locations throughout the region.

In total, 280 individual engagements were hosted.

#### Other feedback

We conducted a meeting with the Anglican Church about the project and notes from the meeting are included in **Appendix II**.






#### What is your age?


#### What is your relationship to the Newcastle Local Government Area (LGA)?





#### Level of agreement with the upgrades to existing plazas:





#### Level of agreement with inclusion of pedestrian friendly shared zones:





#### Level of agreement with the increase in tree canopy:





#### Level of agreement with the improvements to pedestrian crossings:





#### Level of agreement with the upgrades to cycle routes and cycle ways:








#### Level of agreement with the inclusion of alfresco dining options:



Feedback across the other themes identified the need to balance increased activation with **sufficient parking** for residents and visitors, better **cyclist safety** and infrastructure, improved **street design** that **prioritises pedestrians** and **public transport**, and a shift away from **car-centric planning**.

Below is a summary of the top three themes identified as well as a sample of the comments provided.

#### Tree canopy and greenspace

There is support for increasing tree canopy and green space across the Newcastle CBD to enhance comfort, shade and amenity for pedestrians and cyclists, and to create a greener urban environment. However, concerns were raised about converting Wheeler Place into a grassed area. A lawn here is seen as limiting the space's flexibility for events and posing maintenance and safety issues, especially in wet weather. Trees and green areas are supported more broadly but should not compromise pedestrian safety and lines of sight for drivers.

"Greater tree coverage will make it more pleasant"

"I don't support the replacement of paved areas in Wheeler Place as it will limit the use of this area, particularly in wet weather."

"I am concerned that the introduction of green lawn area in Wheeler Place out the front of the Civic Theatre may limit the types of events that can be held in this important civic venue not to mention limit the overflow space for people entering and exiting the theatre. Wheeler Place has successfully hosted a wide range of events that require a flat, durable surface, such as large public screenings of sporting events, licenced pop-up experiences like Pixar Putt Putt, ice skating rinks, and skateboarding exhibitions. Its central location within the civic precinct makes it ideally suited for such activities. These need a level surface and due to safety issues and for public



liability, having a height difference between the concrete and lawn surfaces makes it extremely difficult to implement large scale outdoor events."

"I strongly support the increase in tree canopy, and walkways. This is an improvement on the existing situation."

"Additions of trees and plants on median strips and next to the road obscures visibility, especially when overgrown. Council already struggles to maintain overgrown trees, bushes and plants that obscure traffic signs and visibility. This will make the schedule even worse.

It's already hard to find parking in the city; reduction in parking will make this worse.

Council needs to replace existing trees that are causing safety issues for pedestrians. Pedestrians are currently having slip and trip incidents and these trees have not been removed and their troublesome roots, leaves, seeds etc causing the hazards are not maintained. Current safety issues should be the priority."

#### Pedestrian prioritisation and safety

Respondents generally support greater pedestrian priority, expecting it to make the city safer, more attractive, and easier to access on foot or by bike. Many see this as a way to reduce traffic and support local businesses.

Some feel that shared paths can create conflicts between fast-moving bikes and pedestrians. Suggestions include clearer rules, speed limits, better separation, and traffic calming to protect walkers.

"Further pedestrianising the Newcastle CBD will bring people in and make the city accessible, helping small businesses."

"Cycle and shared pathways are problematic with the increase of e-bikes and their speed."

"Will make the area more accessible and pedestrian friendly."

"The pedestrian crossing between Civic Park and the Town Hall needs to be a raised, well sign posted and lit crossing. Every week I cross it at least once a day and every week I almost get run over.

There is no disability access from the park to the library without going to the end of the block. This is a huge inconvenience for everyone with mobility issues and those with prams.

All of the paths in Civic Park need re-laid as they are cracked, uneven and when it rains, swimming pools. The water today for instance (30/04/2025) was ankle deep and a river ON the paths."

#### **Activation and revitalisation**

Community feedback supported the revitalisation of Civic Park and Wheeler Place to make them safer, greener and more vibrant spaces that encourage cultural events and community use.



Some respondents raised concerns about the lawn areas in Wheeler Place which could limit its flexibility for major events and pose maintenance and safety challenges.

The feedback revealed a desire to balance green upgrades with practical features like durable surfaces, good lighting, and safe pathways to support diverse activities year-round. Overall, people want these precincts activated in ways that attract visitors and reflect Newcastle's cultural scene, without compromising event capacity, accessibility or parking.

"The precincts proposed for improvement are in major need if revitalising to align with modern development that has been undertaken in the city over the past 10 years"

"I am wondering if Civic Park could also have an undercover stage with power for family-friendly community events so rain will not completely wash out performances. This might also allow for more family friendly performances in town.


I believe non-family-friendly performances should not be in public venues."

"Newcastle CBD really needs a big upgrade as the city looks too boring with the existing setup. There are few kids friendly areas, especially at the night. It needs to look and feel modern. Many business shops are closed, there are graffiti's all over the place, at night, the street light is very poor. It looks dull on few streets. I think the city vibe is missing. An upgrade is imminent, as Newcastle deserves better for its local people as well as tourists. We have some of beautiful beaches, but not enough infrastructure to support it, be it parking, walking lanes, bike lanes, kids play area, some kid's play areas.

Please upgrade the CBD street and bring a modern vibe to the place for future generations to enjoy."




#### Level of agreement with the traffic changes identified for King Street:


#### Level of agreement with the traffic changes identified for Auckland Street:




#### Level of agreement with the traffic changes identified for Darby Street:

#### Please let us know why?

Feedback across the themes demonstrated support for traffic changes that **prioritise cyclist** and **pedestrian safety**, improve **street design**, enhance **greening**, support **activation** and **revitalisation**, reduce **car dominance**, and better manage **parking**, with some additional suggestions captured under 'other' traffic-related ideas.

Below is a summary of the top three themes identified as well as a sample of the comments provided.

#### Street design

Feedback identified in the street design theme delivered mixed views. Some respondents support creating more attractive, greener, and pedestrian-friendly streetscapes with improved crossings, lower speed limits, and safer bike infrastructure, but some express concerns about over-planting, narrowed roads, potential congestion, parking loss, and the need for clear traffic flow and well-marked, physically separated bike lanes to ensure safety and ease of use.

"I think it's important to create attractive streetscapes - tree cover and alfresco dining options will contribute - the risk may be creating a sterile or "soulless" gentrified streetscape. Overall the precinct changes look positive in my opinion."

"Whilst I love green streetscapes the draft plans for the streets surrounding the Civic domain appear to have too many large trees and extensive planting sections (particularly planting strips in middle of road) that has the potential to:

- reduce distant vision for drivers in cars and bicycles
- cause slip hazards for pedestrians (footpaths and pedestrian crossings) and bike riders
- increase maintenance/labour costs for street-sweeping and clearing leaf/branch litter from footpaths, kerbsides and gutters
- cause flooding in significant wet periods due to blocked drains
- increase insurance costs due to potential issues above."

"If the concern is solely traffic, these look like a strong shift to promote an easier more pleasant journey through the precinct. I would like to understand more if and how different approaches are being taken in different areas."

#### **Activation and revitalisation**

Feedback in the activation and revitalisation was similar to the previous questions feedback in this theme in that it emphasised the importance of upgrading and modernising the precinct to create a vibrant, safe, and inviting destination with well-lit, family-friendly spaces, attractive streetscapes, alfresco dining, and heritage elements preserved, while ensuring public areas like Wheeler Place remain flexible and practical for events, and balancing revitalisation with access and parking needs to support both residents and visitors.

"Please try to keep all of the beautiful stone walls throughout the park, and even the public toilet block - character comes from heritage, which only happens when things aren't torn down



prematurely and replaced with modern ticky-tacky. Clean it, restore it, adapt and maintain it. Don't trash it. This city has already lost so much of her history."

"It has been years since the road and park were last upgraded. As the city continues to grow and modernize in the 21st century, these improvements are essential."

"All of the streets mentioned above needs upgrade as the thriving city vibe is missing. Newcastle residents and tourists deserve better. Good street lights, enough play area for kids, is required. Also Safety - I believe near McDonalds in the CBD, it's not safe for families to go in night, lot of junkies and poorly behaved kids, also due to poor lighting, no safety is there for families and elder people."

#### Pedestrian prioritisation and safety

Feedback in this theme supported improving pedestrian safety and accessibility through better crossings, wider shared paths, and balanced street design, with some respondents highlighting the need to reduce conflict between pedestrians and cyclists, ensure safe and easy street crossings, especially on busy roads like Darby Street. There was also a desire from respondents to enhance pedestrian-friendly infrastructure alongside reliable public transport options.

"Anything to ease traffic congestion and make the area more suitable for pedestrians has my vote!"

"Good to increase access for pedestrian and cyclists. However simply setting existing paths as shared without widening the paths will lead to increased conflict. (Darby St proposal)

The paths need to be widened (either a reduction of road lane width or within the park) to ensure it is usable to both pedestrians and cyclists."


"In the diagrams I consistently see an upgrade of the pedestrian cyclist infrastructure as as well as an increase in street trees. This is positive for the area. Public transport is also key with the reduction in parking. I support the increase of frequency of public transport services and facilities to the area. However I realise this might be outside the control of the project."



Community feedback supports revitalising the Civic Precinct to reflect Newcastle's vibrant character, with strong emphasis on **safe pedestrian access**, heritage preservation, improved lighting and **maintenance**, but concerns about shared paths, **parking** loss, and the need for **better transport** and **event flexibility**.

Below is a summary of the top three themes identified as well as a sample of the comments provided.

#### **Activation and revitalisation**

The feedback in this theme (as with others across the topic areas) highlights support for revitalising the Civic Precinct into a vibrant, well-maintained cultural hub that celebrates heritage, enables flexible events, adds family-friendly spaces, and balances activation with thoughtful design and noise considerations.

"We need the entire Civic Precinct to reflect the fact that Newcastle is now a vibrant, cultural, mature, cosmopolitan city, both for residents and visitors, and not just a coal port. At the moment, the area is a bit lacklustre and doesn't reflect the way we feel as proud Novocastrians."

"I LOVE the overall planning and concepts for making this a beautiful and vibrant part of Newcastle. Congratulations to those who have worked behind the scenes to develop this proposal. There has been thought put into the aesthetics, as well as the practicalities eg drainage. It will be fabulous to have the additional pedestrian crossings and lights, such as the scramble at King Street, the crossings around Auckland and also in Darby near Finnegans and



the Art Gallery. Hopefully the one way in Auckland will deter traffic that seems to hoon down Laman to avoid Hunter and King street."

"It looks like a positive step for a revitalised Newcastle that will attract tourism and showcase our great city."

#### Safety

Feedback within this theme is concentrated on pedestrian and cyclist safety due to shared paths, poor lighting, missing footpaths, unsafe crossings, and calls for lower speed limits, better separation of travel modes, and safer cycling markings.

"Continued mixing of cyclists and pedestrians has unacknowledged and unaddressed risks."

"There are issues with lighting... toilet blocks... cycle paths.... lack of parking.... litter and rubbish."

"As stated before there are issues with shared paths. Also the plan kind of fizzles out beyond Lambton. Yes make the inner precinct special but, for instance, you cannot walk safely between Wallsend and the University. A distance of about 2.5 Km. There are no footpaths, unsafe crossings and huge roundabouts with hidden pedestrian access. It's a nightmare. If you really want Newcastle to be pedestrian and bike friendly try extending the plan past Lambton."

#### Other

Feedback identified within the *other* theme covers a variety of touchpoints such as commentary around the detail on how cultural and Indigenous heritage goals will be achieved, and questions whether the plan's focus and benefits extend broadly enough to serve the whole community and local businesses.

"In the plan, objectives that include "...diverse activities, experiences and journeys.", "creating meaningful spaces integrated in to the cultural fabric of the precinct..." and "Recognise the commemorate the rich Indigenous (sic) within the public domain", but mechanisms or strategies for achieving this are not outlined in detail.

Questions for me arise including:

- -What is the definition of 'cultural fabric' in this context?
- -How does this plan create more opportunities for diverse activities and experiences considering it's a focus on built environment, what is strategy for supporting business, producers and providers to create activities and experiences.
- -What is the integration with the Cultural Precinct Master Plan there's very brief mention but not a lot of direct or explicit alignment, and in some cases some conflict.
- -How are current tenants and businesses at the west end of the proposed area supported? I would imagine the profile of that part of the precinct is very different to the council owned/run orgs in the central locations, so what different approaches are being taken?



-Where in the plan is there a strategy for recognition of Indigenous Heritage? Beside the retention of public art, how will you achieve this?

"I don't understand how you have a broad urban renewal when there is clearly a narrow focus on a certain area."

"To what end will it serve for only a minority group and not culturally sound for the entire Novocastrians community who have lived here longer?"



#### Do you have any further comments on the draft Civic Public Domain Plan?

Participants were asked if they had any further comments on the Civic Public Domain Plan. Their open-ended responses were analysed and grouped into key themes, which are outlined in the graph below.

Overall, feedback in this section shows strong support for making the precinct more attractive and pedestrian-friendly but raises concerns about reduced parking, limited access, and unclear cultural



and heritage outcomes. Some suggest spreading events across Newcastle, improving safety and traffic details, and ensuring genuine community input rather than change for its own sake.

Below is a summary of the top three themes identified as well as a sample of the comments provided.

#### **Activation and revitalisation**

This feedback in this area showed support for revitalisation and improved public spaces but emphasised the need to maintain flexibility for events, provide convenient access and parking, and called for activation to be balanced across the city rather than concentrated in a single precinct.

"I'm worried that the proposed green lawn in Wheeler Place, right outside the Civic Theatre, could limit the flexibility of this vital civic space. One major concern is that it might reduce the available area for events, especially when theatre-goers are arriving or leaving. Wheeler Place has been home to a wide range of events that need a sturdy, flat surface—think large public sports screenings, licensed pop-up experiences like Pixar Putt Putt, ice skating rinks, and skateboarding exhibitions. The central location within the civic precinct makes it ideal for these types of activities, but they all rely on having a level surface. The proposed height difference between the concrete and lawn would not only pose safety risks but also create significant challenges for hosting large-scale outdoor events."

"Civic Park amenities improvements for events operators are good, perhaps there's opportunity for more?"

"Love it, please make changes in full and as soon as we can!"

#### **Parking**

Feedback within this theme emphasises that reducing parking and removing on-street spaces will create significant problems for residents and visitors, and calls for more convenient and sufficient parking to support access to local events and amenities.

"No one wants to wait at a bus stop in the dark in Mayfield on a rainy night to catch a bus to see an event. more parking is a must so that its really easy to get to this 'precinct' where every even is all happening at once in the same place."

"Please add more car parking areas and spaces."

"Less parking = big problem"

#### Other

Feedback identified within the *other* theme covers a variety of touchpoints such as concerns about unnecessary changes, urges genuine community engagement and respect for local heritage, and



calls for practical planning that balances improvements with preserving parking, managing costs, and addressing maintenance issues.

"Don't make change for the sake of change, please do listen to the community as we use the area daily and care very much about what is done here. So often these community consultations feel like a post decision box ticking exercise; which is such a shame."

"As the representative from Rotary Newcastle, I have communicated with many staff members of CN since 2020. I have written so many letters had several meetings with Council Officers. This project was instigated as a 100 year anniversary acknowledgement to commemorate the wonderful work carried out by Rotarians in and around Newcastle and the achievement of being the 4th Rotary Club established in Australia. Melbourne, Sydney, Brisbane then Newcastle, making this the first regional club in Australia. It has also been the charter club of all Rotary clubs in the Newcastle area, Lake Macquarie, Hunter Valley and country areas of NSW. A huge tribute to the City of Newcastle."

"Overall, there is some really positive built environment strategy that make this precinct a more enjoyable space to move through and potentially dwell.

I don't think this plan yet meet some of it's objectives around diversity of experiences and activation."

A note about sampling bias: The engagement campaign was 'opt-in', which means participants proactively sought to provide feedback as opposed to a sample or respondents being selected to more accurately reflect and represent the population makeup of the Newcastle community.



## 7. Next steps

City of Newcastle will now review all feedback received during this stage of consultation. We will explore opportunities to refine the draft plan in response to community and stakeholder input, ensuring it reflects local needs and priorities wherever possible.


Once these refinements are considered, the updated draft will be submitted to Council for adoption.







The tunnel will remain open, but the path will narrow to one lane (maintenance will take place 6pm - 2am, Monday to Friday).


# Sea Hares at Merewether Baths


A seasonal sea hare spawning event saw hundreds gather in Merewether Ocean Baths this week.

## Community input needed to protect and enhance Newcastle's cultural heart

A new lawn area and event screen in Wheeler Place, better pedestrian and cycling connections, and more green spaces are being proposed under a concept plan for Newcastle's historic Civic Precinct.

City of Newcastle is inviting residents to provide feedback on the draft Civic Public Domain Plan, which will shape the future of an area that includes key streets such as King, Darby, Auckland, Merewether and Hunter, along with important spaces such as Civic Park.

The plan aims to preserve the character of the precinct while improving safety, accessibility and amenity, to create an environment where arts, culture, recreation, and events can thrive.

The intent is to ensure consistency in outcomes, regardless of whether new infrastructure is delivered by City of Newcastle, or by the private sector as part of future developments.

City of Newcastle CEO Jeremy Bath said plans for the area will guide future development with a focus on increasing connectivity between important cultural institutions, while supporting the broader renewal of Newcastle's city centre.

"This precinct has been the focus of significant change during the past 10 years, with major developments helping to shape the character of a key destination for residents, students, and visitors," Mr Bath said.

"The Public Domain Plan will solidify the Civic Precinct as our arts and cultural hub, and elevate Newcastle's reputation as a destination for creativity and cultural expression, with increased opportunities for public art, events and activations.

"It's designed to make the area between Civic Park and Honeysuckle more suitable for walking, riding, and using mobility devices, while also adding more green spaces to make the area more enjoyable and keep the city cooler during hot weather.

"Tree planting will also enhance and protect views of valued heritage items, such as the historic relationships between Newcastle City Hall, Civic Park, Wheeler Place and Christie Place.

"We now need community feedback to help inform key features of the final plan, which will ensure a considered and coordinated approach to future works within the city. All of these features will be reviewed and endorsed by key stakeholder groups, the community, and City of Newcastle."

Newcastle RSL Sub-branch President Peter Griffiths said as a stakeholder with a long connection to Civic Park, the RSL is keen to be involved in the process.

"The RSL wants to ensure the precinct continues to honour the men and women who have served in the Australian Defence Forces," Mr Griffiths said.

"It currently features the WW1/WW2 War Memorial, Vietnam and National Service Memorial, the Folded Wings RAAF Memorial and the Memorial Grove, which includes the Legacy tree.



"We're proud to work with City of Newcastle on this Public Domain plan which acknowledges the fact memorials in Civic Park will continue to be armed service related."

The draft Public Domain Plan is designed to create a seamless and engaging experience for visitors moving between the Newcastle Art Gallery and other nearby cultural institutions such as City Hall, Newcastle Library, Newcastle Museum and the Civic Theatre.

It includes proposed designs for new pedestrian crossings, new and upgraded plazas, as well as footpath and cycleway improvements.

Traffic upgrades to Auckland Street and Darby Street intersections are also proposed, as well as improvements to Christie Park, and acknowledgements of First Nations history and early European settlements.

The draft Civic Public Domain Plan is open for feedback via City of Newcastle's website until 20 May 2025.

Community members can also join interactive "walkshop" events through the precinct on 2 and 3 May or visit City of Newcastle staff at the Olive Tree Markets in Civic Park on 3 May.


